For 30 years, the European Union has funded the Erasmus programme which has enabled almost 4 million European students to spend part of their studies in another higher education institutions (HEIs) or with organisations in Europe.

Eligible partner countries and eligible organisations are shown in the table, below (Erasmus+ ICM Handbook for participating organisations, p.4 & 6). All countries highlighted in bold are allowed not only to send but also to host students on Bachelor and Master level as high income countries based on OECD's DAC list.

# Selection rules for Students

Applications have to open for that all students study in the related department which is aggreed on.

Undergraduate students are required to have a GPA of 2.20/4.0. and postgraduate (master and PhD) students a GPA of 2.5/4.0. Their level of English language must also be evaluated. The Erasmus+ success grade will be calculated as follows:

50% English language grade + 50% GPA

Social inclusion paramaters (economical, physcial etc) take into consideration and be pointed.

Applications have to be evaluated transperently, fairly and objective. Latter they approved by the Selection/Executive Board and process have to be documented in digital and real archives.
