Akdeniz University is pleased to announce the results of application process for incoming students and staff within the framework of the Erasmus+ Programme (KA171 – International Credit Mobility/International mobility involving third countries not associated with the Programme), the project **2023-1-TR01-KA171-HED-000167408** funded by the European Commission.

1. Evaluation Process

All applications received were carefully evaluated by the Akdeniz University Erasmus+ Selection Committee in line with the Erasmus+ Programme rules and the principles of fairness, transparency, and equal opportunity.

Applications were assessed based on:

- Completeness and accuracy of the submitted documents,
- Compliance with eligibility criteria (including departmental match and partner institution agreement),
- Academic/Professional relevance and motivation.

2. Application Timeline

- Announcement Publication: 29.09.2025
- Application Deadline: 21.10.2025 – h: 17.30 (TR time)
- Results Announcement: in November
- Withdrawal Notification Deadline: a week after the result announcement
- Final Results Announcement: in November
- Planned Mobility Period: one week till the end of March 2026

3. Results

- Applications with missing or incomplete documents,
- Applications submitted by candidates from non-eligible or different departments, were not considered eligible and therefore rejected in accordance with programme rules.
- Applicants who submitted all required documents completely and correctly and met all eligibility criteria were accepted for participation in the Erasmus+ KA171 mobility activities.



4. Teaching/ Training Mobility

- Teaching Mobility: **8 hours/a week** of teaching in the Academic Year. Days of courses should be min. 5 following days.
- Training Mobility: Days of courses should be **min. 5 following days**. It is possible for staff to receive various training programs (such as on-the-job training and observation sessions) to develop their skills related to their current job. Attending conferences is not considered eligible for staff training.

5. Financial Support

- Financial support is provided within the framework of Erasmus+ KA171 Project grants.
 - Individual support: 140 €/per a day (teaching days for mobility + 2 days for travel will be granted)
 - Travel support: Travel support: For Azerbaijan, Kosova and Moldova: 275 €
For Cameroon, Thailand and Sri Lanka: 820 €
For Australia, USA and Canada: 1500 €

NOTE: In case of using sustainable means of transport (green travel), a declaration of truth signed by the person receiving the travel grant and the sending institution will be requested from the beneficiary, as well as supporting documents such as boarding passes, bus/train tickets/passport entries and exits to determine the departure and return dates.
