The concepts of strategy, business policy and other planning concepts; analysis of the external and internal environment, SWOT analysis, resource based view and value chain approach; organizational vision, mission and objectives, first level and second level strategies; diversification and withdrawal strategies at the corporate level; portfolio analyses, competitive strategies; functional level strategies, implementation and control processes are main topics to be studied. ULS 221	Histoire Politiques I	Fall	In this course, information about history discipline will be given briefly and at the end of the Middle Ages, especially in Europe, the situation in the world and will be examined. The political structures of the actors in the international system, the events and the wars affecting the system will be evaluated. ULS 329	La Vie Politique Turque ( Türk Siyasal Yaşamı)	Fall	The scope of the course covers the transition to multi-party life and various issues related to Turkish politics since 1960. Constitutions and constitutional changes, basic institutions (legislative-executive-jurisdiction), elections and election systems, political parties and party system, political culture and voting behavior, military-civil relations, Islam and politics, Kurdish problem, political corruption and political regime discussions are the main subjects of the course. ULS 331	Regional Politics: The Middle East	Fall	The course aims to give the students a general understanding of what/where the Middle East is and of its various historical-political, socio-economic, cultural, ethnic and religious characteristics. It enables students to understand how certain Middle Eastern states were formed and analyze their emergence and development in historical context. In addition to investigating the internal dynamics of Middle Eastern states such as their political and economic structure, the course also analyzes the interaction of different Middle Eastern societies with each other and their impact on international politics. Thanks to the investigation of historical developments and the global political system, the course also helps the students to understand the current political situation in the Middle East. The course starts with a discussion of the region prior to World War I. We will analyze what the term “Middle East” means, its implications and connotations. Then we will continue with World War I, the collapse of the Ottoman Empire and the reshaping of the Middle East in its aftermath. Then we will move on to analyze the region during the interwar period and the Cold War years. Finally, we will focus on recent historical developments such as the Iranian Revolution, Iran-Iraq War, the Gulf Wars and the Arab Spring.	Dr. Öğr. Üyesi Fulya ÖZKAN		International Relations

The course will also provide students with a general discussion of political concepts such as imperialism, hegemony and balance of power. The course starts with a brief survey of the Middle Ages and Early Modern Period. Then we will focus on the "long" 19th century developments such as the American Revolution, French Revolution, 1830-1848 Revolutions and the Industrial Revolution. Towards the mid-semester, we will analyze the emergence of nation-states, colonialism and the causes and consequences of World War I. In the second half of the course, we will focus on the 20th century and cover topics like the rise of fascism in the interwar period and the Cold War in the aftermath of World War II.
